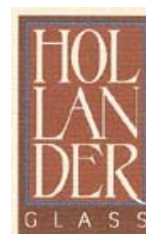

Wholesale Buying Application and Purchasing Policy

Since we are strictly a distributor to the glass industry, we are careful not to send our wholesale pricing to unqualified customers. We do this to protect our valued customer base.

All information submitted is confidential and intended for the sole use of Hollander Glass Canada Inc. Using your Web Browser's print button, please print, then complete all parts of this form, and return it to Hollander Glass Canada Inc. along with:

- > Your business card
- > Letterhead or advertising indicating a glass business
- > A copy of your Provincial tax license if you are an Ontario resident (if your province does not have a Provincial sales tax, a copy of your Federal or Provincial business registration may be substituted)
- > Business registration from your town or municipality which reflects a stained glass studio, retail outlet, or related business
- > A business cheque for \$20.00 to cover the cost of the catalogue (the \$20.00 deposit will be refunded as a credit when your first order is placed)

Additional requirements...

- > A business account with your financial institution (copy of a void business cheque)
- > Purchases are done using business cheques, Visa, Mastercard and Debit Card. Personal cheques are not accepted.
- > An initial minimum purchase of \$2,000.00 net of tax (Note: The purchase of a kiln is not included as part of the initial \$2,000.00).
- > To maintain purchasing status an annual minimum purchase volume of \$2,000.00 in our fiscal year (April 1st to March 31st)

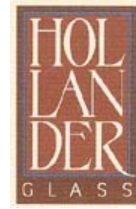

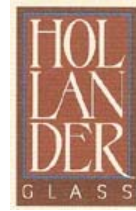

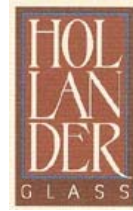
